**16.123** Police report: Presented by PCSO Steve Blanks.

Information on setting up and running a Drivesafe scheme had been emailed to the Clerk.

Crime Figures: between 1 September and 1 November 2016 there were four reported crimes in the Parish (compared to five in the same period last year). These comprised 1 x theft from motor vehicle, 1 x theft of motor vehicle, 1 x theft of straw bale, 1 x burglary dwelling.

Other News: We are currently having issues with off road motor vehicles driving across fields within the East Herts rural area. We have also had issues of theft from motor vehicle offences and motor vehicle interference, mainly in Standon and Sawbridgeworth. Yesterday, two persons were arrested regarding this.

We are aware of parking issues in and around the Benningfield Road area of the village. We will be attending the area, warning notices will be placed on offending vehicles, and when needed, parking tickets will be given out.

The caravan that has been parked in the layby for many months has been reported as stolen – it had been thought the owners had finally moved it.

The Chairman thanked PCSO Blank for attending and he left the meeting at 8.05pm.

  - 1.1 Late notifications: EHC consulted the Parish Council on its proposal to name the Wilmoor development "Lilly Wood Lane". Following a discussion with members of the public, it was agreed and RESOLVED to advise that "Lilley Wood Close" would be more appropriate and acceptable.

**2. Report on EHC Planning Training Event, 18th October.** Cllr Paul Riddle reported: Two weeks ago, Cllr Jill Buck and I attended a Training Seminar at East Herts District Council. The purpose was to update parish councils on the progress of the new District Plan and to tell us what to expect next. The main speaker was Mr Kevin Steptoe who is the Head of Planning and Building Control. Mr Steptoe spoke about the planning process and the value of Neighbourhood Plans. However, it soon became clear that he views Neighbourhood Plans through the prism of the Development Committee and this is not exactly the same as the view of Linda Haysey who rightly sees things from the planning policy viewpoint.

The community is soon going to be asked if it feels that Widford needs to produce a Neighbourhood Plan and the Parish Council clearly wants to present a balanced view of the pros and cons to support that decision-making process.

The following points became clear during the Training Seminar.

- 1. East Herts District Plan should be adopted by the middle of 2017. If the plan fails evaluation this may have an impact on Neighbourhood Plans which may need to be revised to comply with the District Plan. Kevin Steptoe felt that Parish Councils should continue to produce their Neighbourhood Plans but suggested that there was no immediate rush.
- 2. The new District Plan requires East Herts to deliver a 5-year supply of housing land and if the Council should fail in this commitment, the entire Plan, and any Neighbourhood Plan, will once again become invalid.
- 3. It may be that it is in the interest of developers that East Herts fail to deliver their 5-year plan as this would allow the developers greater flexibility in the planning process and of course it would be a simple matter for them to create a delay and force East Herts to a position of failure.
- 4. Neighbourhood Plans cannot restrict development even where a specific housing target has been met. The NPPF (National Planning Policy Framework) will always support the presumption in favour of development.

At this point, Cllr Riddle wished to comment on the Neighbourhood Plan and it was agreed to bring agenda item 16.127 forward. He made the following points:

- A Neighbourhood Plan is a major exercise that involves a great deal of time and effort.
- It must be produced by parishioners and with input from all sectors of the community.

- It must not create expectations that cannot be met.
- It would be expensive; £15k is not an unrealistic estimate of the cost.
- It would not provide any protection against wider development.

It was necessary to hold a public meeting to assess the will of parishioners; this should be in January and advertised in the parish magazine as well as leafletting every household. Planning Consultant Lorraine Hart and East Herts Senior Planning Policy Officer, Laura Pattison, should be invited to address the meeting if they are available. It was **RESOLVED** that Lorraine Hart and Laura Pattison be asked for dates when they would be available to attend; then a leaflet should be printed and the VH should be booked.

#### 16.126 Report by County Cllr Roger Beeching.

Concerning Martlets, ClIr Beeching confirmed that no Highways Section 106 money had been secured because no measures were considered to be effective in producing the result expected by the Parish Council. Priorities may change in the future. The question of reported £150k s106 payments for Hunsdon was raised and ClIr Beeching said that £10k per house would be about right.

The damaged Nether Street railings have been referred to Ringway for repair quotes. However, the repairs will not be undertaken until next financial year. Highways have inspected the site and have reported that the damage presents no danger.

County has undertaken a scrutiny into flooding, but Cllr Beeching said he would report on this at a later meeting.

He congratulated the editors of the Widford Parish Magazine for their excellent work - and said he was looking forward to following the pumpkin soup recipe!

Cheques for 1st November were signed at the end of the meeting.

**3.** Budget/Precept 2017/18. The Clerk presented the current financial position against budget, and the projected bank balance at year-end, 31 March 2017. This showed an anticipated year-end balance of £5,258, against a budgeted balance of £6,202 (including £500 ringfenced for the F Cooper churchyard seat). The £944 deficit is mainly attributable to unprecedented and unanticipated parish maintenance expenditure in the closed churchyard during the current year. An application has been made via HAPTC for a grant of £397.84 to defray additional administration costs as a consequence of the Government's Transparency legislation. Members agreed to meet informally to consider budget and precept options for 2017/18 so that decisions can be agreed at the January Parish Council meeting. It was unanimously **RESOLVED** to accept the budget report.

**5. Precept cap.** It was noted that HAPTC has drawn the attention of parish councils to the possibility a future change in the law that could result in their precepts being capped (possibly at 2%) following a local referendum. This would hamstring councils if unexpected expenditure arose and they held insufficient reserves.

The tenant of an unworked plot has relinquished their tenancy, whilst three new
tenants have taken plots. There have been further problems with the horses and some
damage was caused to tenants' produce and plots. The Parish Council is considering
further fencing options under its duty of care to tenants. There has been no reply to a

letter written to Anita Buxton asking for clarification on the ownership of the North-Eastern boundary fence when she owned the stables. The new post and rail fencing bordering the licenced paddock was installed in September.

2. Risk Assessment: It was agreed to make amendments to the Risk Assessment. GM Fencing has been asked for effective fencing solutions and prices.

#### 3. Playing Field

1. Report: GP

- The annual RPII report revealed several things that needed attention. The Clerk advised that EHC would consider making a grant for safety repairs under its small capital grants scheme. The closing date for the next round of grant applications is 19th December.
- Section 106 funding from the Martlets development is still under consideration for hard standing to be created for the car park area.
- The dog bin has been installed at the playing field entrance and the emptying contract with EHC has been set up. Financial arrangements for the purchase and cleaning contract have yet to be finalised between the Playing Field Committee and the Parish Council.
