16.024 Budget and Precept for 2016/17

There was a discussion on the elements of the budget. It was agreed to keep under review the amount granted towards maintaining the Playing Field by taking account of the income from football clubs, whether the footballers mowed the pitch themselves, and the costs incurred in mowing of the pitch and the rest of the field at other times.

Furthermore, essential safety work in the closed churchyard had incurred unforeseen expense in the current year, and further safety work on a large lime tree was anticipated, subject to East Herts Arboricultural Officer's approval. In recognition of this it was agreed to not make a grant toward the upkeep of the New Churchyard in the coming year. The Chairman will write to the PCC.
