# 20.045 It was agreed to bring the Cllr Eric Buckmaster's County and District Councillor reports forward:

<u>Highways</u>: under Covid-19 restrictions, will continue to catch-up with the programme but not within the original time-frame – apart from gulley cleaning.

<u>Covid-19:</u> updates have been sent out regularly to parishes. HCC continuing to check on those needing support, about 80% being helped locally. Volunteer Groups are working well.

<u>Waste & recycling:</u> HCC opening 4 sites initially, but not in East Herts. It is anticipated that 11 of the 17 sites will open asap. Traffic management will be organised to mitigate risks of vehicles queuing. Green household waste collections will resume on 11th May. The new Ware site will hopefully be opening late summer.

<u>Projects:</u> Will continue as planned as much as possible, including Grange Paddocks, Hartham and Hertford Theatre. Looking at ways to use new technology to engage and consult.

<u>Small Business Grants:</u> More money needed from government on top of the £31m already provided. From next week, a further £1.5m will be available for other small businesses – guidelines are yet to be published. There is a request to let local businesses know that they

 might get help if they need a grant.
